- Jaelyn Scanlan, Public Health Officer, provided updates on events happening soon including car seat checks taking place at area libraries and reading a book on distracted driving, a hot car display at will be at the Oconto County Fair and Gillett Summer Splash, Scanlan will be attending multiple National Night Outs (NNO) in the area including presenting on the dangers of graduating from a booster seat too soon at the Suring NNO.

- Safety Town is scheduled for August 27<sup>th</sup> and 28<sup>th</sup> in the LEC conference center. This is in partnership with the Nonprofit Childcare Center.
- Jennifer Austin, WI State Patrol, will be attending National Night Out events coming up in the area.

## **6. Locations of Traffic Hazard and Recommended Improvements to Enhance Safety**

- Sheriff Skarban brought up the speed limit and cross walk on County I in relation to the new Middle School. There is a request for reducing speed limits on portions of County I. Commission discussed compliance, an urban cross section with curb, gutter and overhead lighting. Discussion of a traffic study or traffic engineering evaluation, safe systems with a content based review, discreet speed eyes to gather data based on traffic patterns, if Baylake Regional Planning could be a resource, and the fences put up in Luxemburg to control access and direct everyone to the designated crossing areas. More discussion followed. Informational only. No action taken.
