1. Call Meeting to Order

6. Oconto County CLTS Enrollment/Waitlist
Teresa Esela reported there are 134 youth enrolled in CLTS. There are 23 youth on the waiting list.
7. Statewide CLTS Enrollment/Waitlist
Esela reported that Statewide, there are 27,636 youth enrolled in CLTS and an additional 1,106 youth on the waiting list.
8. CST update
Getzloff reported that as of today there are 13 youth enrolled in CST. One client met all of their goals and was successfully discharged from the program. Getzloff also reports that roughly half of the enrolled youth are between 11 and 12 years of age. Discussion followed regarding referrals to the CST program. Most referrals are coming in from a County employee. There are also quite a few referrals that come from schools within the County.

- Stascak shared that there is a full time opening for a CLTS/CST supervisor.
- Committee discussed moving the start time of the meeting. It was agreed that the time would be moved from 12:30 p.m. to 8:30 a.m.
- Discussion held regarding possible future agenda items. Going forward Dey will reach out to the entire group to gather possible agenda items. Deviley will be presenting at the next meeting regarding the MAPCW services and the PCS tool.
